# **Hendrix House (Bramall Close)**

We are pleased to issue the October newsletter for the construction works of 16 new homes at Bramall Close.

Over the past few weeks, the groundworks have continued, and the Section 278 works have begun. The site compound at Idmiston Road has been cleared and the last of the landscaping and ground works have commenced. The landscaping at Hendrix House is completed and the main building works have been finished. Testing, commissioning, and snagging works are still to be completed. The flooring in the houses has been laid and the second fix items and bathroom sanitaryware have been installed.

Over the coming weeks, the ground works will be completed and the Section 278 work including tarmac and lining will be carried out. The houses will be completed and the snagging and desnagging will take place. After these works have been completed, the buildings will be ready for handover to the client.

#### Interested in one of these properties?

Please check first if you are eligible to be on the Housing Register, you can do this by visiting <a href="www.newham.gov.uk">www.newham.gov.uk</a>, and selecting Apply and then Housing Register, this will give you details on who can apply and how to do so. If you're eligible to register, once your application is submitted it will be assessed and you will receive an email informing you whether you are eligible to bid for properties.

The London Borough of Newham operate a Choice Based Lettings (CBL) Scheme; applicants who are eligible are asked to bid for properties that become available. The properties will then be allocated based on priority and waiting time.

Please note, due to current demand for social housing, applicants are having to wait for extended periods of time to bid successfully. Once they are ready, these properties will be advertised for applicants to bid on, there is no other way to apply for one of these properties.

#### Working Hours

Working hours on site are between 8:00-6:00pm Monday to Friday (excluding bank holidays). In exceptional circumstances we may need to work on some Saturdays between 8:00-1:00pm. Some staff will arrive earlier in the mornings to accommodate travel arrangements but will not start any work before 8am.

## **Site Security**


